Therefore, we implement several projects on key issues of banking and non-banking financial systems. Based on the key success factors of the Sparkassen (German savings banks) model, we work to find practical solutions together with our partner institutions. With this objective in mind and a strong social focus, we adapt the proven know-how of Sparkassen to the context and needs of each country, region, and locality, so that this translates into better living conditions and continues even after the projects have been completed.





Our work in Latin America and the Caribbean

- Since its creation in 1992, the *German* Sparkassenstiftung has been active in Latin America and the Caribbean and has implemented more than 15 projects there. Nowadays, we are present in 17 countries in the region: Antigua and Barbuda, Argentina, Bolivia, Colombia, Costa Rica, Cuba, Ecuador, El Salvador, Guatemala, Haiti, Honduras, Mexico, Panama, Paraguay, Peru, St. Lucia, and St. Vincent and the Grenadines.
- Our donors in the region include the German Federal Ministry for Economic Cooperation and Development (BMZ), the World Bank, the Inter-American Development Bank (IDB), and the International Fund for Agricultural Development (IFAD). We are constantly on the lookout for other funders and opportunities to participate in new projects.
- Special mention should be made of our subsidiary, Fundación Alemana Servicios (FAS), founded in 2006 with the objective of carrying out specific training and consulting activities for financial institutions in Mexico and Latin America, especially those in the social banking sector operating in rural or marginalized areas.

Cutting-edge topics in the region

Within the core topics that German Sparkassenstiftung has been incorporating in its projects for 30 years, in Latin America and the Caribbean we are introducing innovative and strategic solutions to help our partners meet today's challenges.

- ▶ We develop cross-cutting strategies for the digitalization and digital transformation of financial institutions, in order to strengthen them, improve their competitiveness, and expand their financial services offering – thus benefiting clients and satisfying their needs. Based on the Sparkassen Finance Group's experience, we assist our partners so that their efforts in this area are successful and aligned with their objectives. We also foster alliances with technology developers and other key players to create digital ecosystems. In 2021, we started a project in six Latin American countries, which is financed by the International Fund for Agricultural Development (IFAD) and focuses on linking technology companies with farmers to facilitate access to financial services.
- Furthermore, we implement "green finance" initiatives, i.e., the development of financial products that promote investments in renewable energies and green technologies. By doing so, we reaffirm our commitment to the environment and to climate change adaptation, also endorsed by Sparkassen, Germany's leaders in financing green projects.



Since 2020, we have carried out different projects in Colombia and Peru aimed at the economic integration of migrants from Venezuela, so that they can fully participate in the host countries' economic system. German Sparkassenstiftung developed a global migrant integration strategy that can be adapted to local contexts.

It is worth mentioning that we always drive **innovation** in our projects, for example, by digitalizing our professional training and financial education courses, cocreating disruptive solutions, introducing the dual training model and the comprehensive customer advice, etc.

We are part of the **Sparkassen Finance Group** (Sparkassen-Finanzgruppe), Germany's market leader in private and corporate banking and one of the largest finance groups in Europe. We are backed by more than **240 years** of experience of Sparkassen (German savings banks), whose model of regional financial institutions combines profitability and a social mandate and has proven that sustainable financial inclusion is based on professionalism and efficiency. We work to strengthen **microfinance institutions** to support the development of financial products and services tailored to the local population's needs. 
Who supports the German Sparkassenstiftung?
